County Attorney Andrew Heap gave an update on the lease agreement with the landowner in the Harper area that is willing to let Kimble County lease roughly one acre of property to place a new building to use as the voting location for precinct 7 since the County lost the use of the old Knoxville schoolhouse. Lease to be ready for review and acceptance by the commissioners by the next meeting
- 12. Consideration, discussion and possible action on accepting resignation from and open positions on the Kimble County Historical Association Board and appointments replacing them on the Board.
  - a. Commissioners discuss and accept the resignation letter of Charles Haygood. Motion made by Commissioner Simon, second by Commissioner Hoffman, all in favor, motion carries.

A second motion was made by Commissioner Simon to replace the seats of the late Frederica Wyatt and Billie Noguess, KCHAB made a recommendation of Wyatt Burton and Vanessa Childress to replace the open seats, Commissioner Simon made the motion to accept these recommendations, second by Commissioner Shultz, all in favor, motion carries.

The new contract will be paid quarterly at the rate of \$531.63/quarter which is an increase of \$107.79/quarter from the previous contract. Motion to accept and approve the new Pitney Bowes contract made by Commissioner Simon, second by Commissioner Dunagan, all in favor, motion carries.

# 16. Consideration, discussion and possible action on contract between Frontera and Kimble County for providing mental health services to inmates.

a. The sheriff, County Attorney and commissioners discussed signing a contract between Kimble County and Frontera Healthcare Network to provide mental health services to inmates which is state mandated. County Attorney, Andrew Heap spoke about the memorandum of understanding currently in place with the hospital district and mentioned there should not be a conflict if the commissioners agreed to signing the interlocal agreement with Frontera. Motion to approve the interlocal agreement and have Judge Rose sign the contract made by Commissioner Hoffman, second by Commissioner Simon, all in favor, motion carries





# Frontera Healthcare Network PROFESSIONAL SERVICES AGREEMENT

This Professional Services Agreement (the "Agreement") is entered into by and between Frontera Healthcare Network (hereinafter referred to as "Contractor"), and Kimble County.

WHEREAS, Kimble County is in need of procuring the services of the Contractor to provide Behavioral Health and Medical care to inmates at the county jail.

WHEREAS, Kimble County and Contractor find that their desires and objectives will be mutually well served by agreement between them on the terms and conditions set forth hereinafter.

**NOW, THEREFORE,** in consideration of the foregoing and of the terms and conditions set forth herein, the parties hereto agree as follows:

1. <u>Retention</u>. Kimble County hereby retains Contractor for the services (hereinafter referred to as "Professional"), and Contractor hereby accepts such retention, subject to the terms and conditions set forth herein. Contractor shall meet all qualifications, conditions and obligations set forth in this Agreement.

2. <u>Compensation</u>. Billing for services will be at a rate of \$35.00 per visit for the project. Contractor will send billing statements in a timely manner to the Kimble County Treasures Office. Kimble County agrees to pay the visit rate listed in this agreement within 30 days of receiving statement.

3. <u>General Conditions</u>. The following general conditions govern Contractor's performance under this Agreement:

a. <u>Records</u>. All patient records, charts, and personal or regular files concerning patients receiving services shall belong to and remain the property of the Contractor. Contractor will provide documentation to Kimble County Jail in accordance with HIPAA regulations in order to ensure continuity of care. Contractor agrees complete all records and reports in a timely fashion. Each party expressly agrees to maintain the confidentiality of all medical records and confidential clinical information.

b. <u>Relationships</u>. Contractor shall establish and maintain positive working relationships with staff members at Kimble County Jail.

c. <u>Policies</u>. Contractor shall comply with applicable bylaws, rules and regulations, and policies of Kimble County in delivering services under this Agreement.

d. <u>Current Knowledge</u>. Contractor shall maintain and demonstrate current working knowledge in all aspects of his or her profession relevant to his or her responsibilities under this Agreement. This shall include requiring attendance at programs of continuing education, as appropriate.

e. <u>Treatment</u>. Initial visits will be in person in the clinic with an appropriate authority present at all times. Subsequent visits may be virtual as long as the provider feels it is appropriate and the county jail has access to a stable internet source with a webcam and microphone. Contractor reserves the right to not treat if patient does not desire medical or behavioral intervention, has conditions outside the scope of practice of primary care, or violates patient's rights and responsibilities agreement. In the event the patient needs a higher level of care or violates the patient's rights and responsibilities agreement, contractor will refer out to the appropriate provider per their policy.

4. <u>Term and Termination</u>. Except as otherwise provided in this Agreement, this Agreement shall begin when executed and renew annually unless either party gives at least (30) days advance written notice to the other of his/her/its intention to terminate.

5. <u>Miscellaneous</u>.

a. <u>Entire Agreement</u>. This Agreement constitutes the entire agreement between the parties and subsumes and incorporates all prior written and oral statements and understandings.

b. <u>Amendment</u>. This Agreement shall not be supplemented, amended or modified except upon the express written agreement of the parties.

c. <u>Parties</u>. All terms of this Agreement shall be binding upon, inure to the benefit of, and be enforceable by the parties hereto, their heirs, their respective legal representatives, successors and assigns.

d. <u>Severability</u>. If any term, provision, covenant or condition of this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of the provision, covenant, or condition shall remain in full force and effect and shall in no way be affected, impaired or invalidated, unless to do so would substantially destroy the fundamental purposes of this Agreement.

e. <u>Waiver</u>. Any waiver by a party of a breach of any provision of this Agreement shall not operate as or be construed as a waiver of any subsequent breach thereof, and the obligations of such party with respect thereto shall continue in full force and effect.

f. <u>Governing Laws</u>. This Agreement shall be interpreted, construed and governed according to the laws of the State of Texas.
