Meeting was called to order at 8:10 A.M. by Judge Rank Cogdell.

Open Forum: Judge Cogdell recognized the Briscoe County Sheriff's department and members of the TxDot department for rendering aid to an individual involved in a wreck while passing through Briscoe County. Judge Cogdell also informed the commissioners that TxDot had seal coat rock available upon request.

Motion was made by Commissioner Francis to approve the minutes from the July 10th commissioners court meeting. Seconded by Commissioner Wellman, passed with a 5-0 vote, it is so ordered

Motion was made by Commissioner Wood to approve the minutes from the July 24th commissioners court meeting. Seconded by Commissioner Wellman, passed with a 5-0 vote, it is so ordered

Motion was made by Commissioner Wood to nominate Judge Rank Cogdell for Briscoe County Tax Appraisal District Board of Directors. Seconded by Commissioner Burson, Judge Cogdell abstained, passed with a 4-0 vote, it is so ordered.

Motion was made by Commissioner Wellman to approve work orders: Precinct #1, Ken Wood, \$75.00 and Precinct #1, Burson Cattle Company, \$125.00. Seconded by Commissioner Wood, passed with a 5-0 vote, it is so ordered.

Motion was made by Commissioner Francis to schedule September 18th and September 25th as regularly scheduled commissioner court meetings to be held at 9:00 AM. Seconded by Commissioner Wellman, passed with a 5-0 vote, it is so ordered.
