Open Forum: Judge Cogdell informed the court that County Procurement went from \$50,000 to \$100,000.

Motion was made by Commissioner Burson to approve the minutes of the August 25, 2025 meetings, as presented. Seconded by Commissioner Wellman, passed with a 5-0 vote, it is so ordered.

Motion was made by Commissioner Burson to approve the 2025-2026 jail contracts with Garza, Childress, and Swisher Counties as presented. Seconded by Commissioner Francis, passed with a 5-0 vote, it is so ordered.

Motion was made by Commissioner Wellman to approve the purchase of a shredder for Precinct 3 for up to \$15,000. Seconded by Commissioner Burson, Commissioner Francis Abstaining, passed with a 4-0 vote, it is so ordered.

Motion was made by Commissioner Wellman to dissolve the partnership of shared equipment between precincts, specifically the semi/trailer, New Holland tractor, boom shredder, and loader. Report on action will be made to the court. Seconded by Commissioner Francis, passed with a 5-0 vote, it is so ordered.

Motion was made by Commissioner Burson to approve Precinct 2 to purchase signs for CR 28, CR 29, and CR FF that indicate the roads are unmaintained. Seconded by Commissioner Estes, passed with a 5-0 vote, it is so ordered.
