Meeting was called to order 9:00 A.M. by Judge Rank Cogdell

Open Forum: Judge Cogdell informed the court how future surplus in the budget would be handled, asked if anyone wanted a refresher on Robert's rules for Commissioner's Court, clarified that payments for signposts from the city would go into General fund, and that he had given Ashley Knight approval to pay a bill from CopSync. Commissioner Francis discussed raising the credit card limit or getting individual cards. Ashley Knight discussed direct deposits and direct payments. Commissioner Wellman discussed obtaining culverts from Paradigm.

Motion was made by Commissioner Francis to approve the minutes of the October 14th, 2025 meetings, as presented. Seconded by Commissioner Wellman, passed with a 5-0 vote, it is so ordered.

Discussion was had with Anthony Kingery, from the historical committee, on commemorative county books and 150th anniversary plans.

Motion was made by Commissioner Wellman to approve the resolution for TDA Texans Feeding Texans Grant Program 2026. Seconded by Commissioner Francis, passed with a 5-0 vote, it is so ordered.

Discussion on use of lateral road fund

Motion was made by Commissioner Burson to approve the bid for electrical work at show barn for \$3,500 by City Electric for precincts 1, 3 and 4. Seconded by Commissioner Estes, Commissioner Wellman and Judge Cogdell abstaining, passed with a 3-0 vote, it is so ordered.

Motion was made by Commissioner Estes to add Judge Cogdell to the Tax Assessor and Treasurer cash management accounts as the supervisor. Seconded by Commissioner Burson, passed with a 5-0 vote, it is so ordered.

Motion was made by Commissioner Burson to approve the veteran's van re-wrap for \$6,100 to come out of the yearly budget reimbursement from the veteran's van grant. Seconded by Commissioner Francis, passed with a 5-0 vote, it is so ordered.






