Lynn County Commissioner's met in first regular session on Monday, March 11, 2013 at 9:15 a.m. in the County Courtroom. Commissioner's Wied, Braddock, Blair and Martin were present with the County Judge presiding.

Agenda Item #2: Approve minutes of previous meeting

Commissioner Mike Braddock moved to approve the minutes from February 25, 2013 and Commissioner Wied seconded the motion with all in favor.

Agenda Item # 3. Consider and act upon Burn Ban

No action was taken.

Agenda Item #4: Discuss and act upon bid from Tim Pledger concerning I.T. Services

Commissioner Don Blair moved to sign a contract with West Texas Computer Services owned by Timothy Pledger. Commissioner Braddock seconded the motion with all in favor.

Agenda Item # 5: Open and act upon sealed bids for the purchase and removal of building material located on the property commonly referred to as the "Louder Gin"
