


NOTICE OF MEETING

17. Consider and act on awarding bid for Exterior Cladding & Renovation to the Schubert-Fletcher Heritage House and Cottages.



18. Consider and act on authorizing a Commissioner to negotiate the purchase of a bucket truck for all commissioners' precincts.
