



16. Consider and act on appointment of Crystal Smith as unpaid assistant to the Lee County Veterans Service Officer.



17. Discuss and propose the 2017 Tax Rate, if the proposed rate exceeds the calculated effective rate take a record vote and schedule the required public hearings.
