


NOTICE OF MEETING

17. Consider and act on agreement with the Texas Department of Transportation Airport Coronavirus Relief Grant Program.


18. Consider and act on request from the Sheriff's Office to use the Lee County Courthouse lawn on July 30, 2021 for Family Fun Night.
