Delia Grisham, Juvenile Probation stated the current office has been the Veterans Service office for at least 28 years and is known as the veterans office and Johnny Hernandez being in the military and on the same floor as her has helped her out with some of her clients. Commissioner Rosson and Commissioner Elder stated they wanted this item tabled until they could meet and discuss this issue with all involved.

Dude Speed, TDEM Coordinator, stated the need for a liaison officer in Gaines county to assist in duties during disasters and working with the EOC with a salary of \$50,000.00. He also stated there would be a need for office space provided by the county and provided a copy of the Interlocal agreement that the county would sign if this was approved. This item was tabled until further information is gathered and the Interlocal agreement is reviewed by Joe Nagy, County Attorney.

6. Discuss, consider and/or act on relocating the Veteran's Service Office to Room 102 in the courthouse to provide easier access for veterans.

Commissioner Rosson made a motion to approve relocating the Veteran's Servive Office to Room 102 in the courthouse with a proposed date of May 10, 2023 and Judge Therwhanger will place an article in the newspaper explaining the Veteran's Service and the move. Commissioner Elder seconded the motion. Motion carried unanimously.

Discuss, consider and/or approve for county employees to opt out of medical cards with a waiver from DOT.

Commissioner Murphree stated medical cards for DOT was not a requirement unless you traveled out of state and the \$80 reimbursement to employees did not cover the cost as some places charged a higher fee. Therefore, he stated he wanted his employees to sign a waiver with DOT as he does not travel to out of state to purchase rocks.. Commissioner Elder stated he does go to Hobbs, NM to purchase rocks and his employees would need to have this. Following much discussion this item was tabled for further information regarding cost and to possibly increase the reimbursement to employees. (see attached)

 Discuss, consider and/or act on purchasing an additional irrigation system for the south cemetery. Total cost: \$96,070.00

Commissioner Houston stated he had an individual wanting to donate mony for this project, however he was concerned they would try to state as what and when things are to be done. Commissioner Rosson stated a contract need to be done for the individual to sign and state once the donation is received it is the counties and they do not have authorization regarding any decisions on the cemetery. Commissioner Houston made a motion to approve the purchase of four tanks from Pate Trucking in the amount of \$38,270.00 to be paid out of the ARPA funds. Commissioner Murphree seconded the motion. Motion carried unanimously. (see attached)
