- 5. Meet with County Attorney, a representative of the Public Health Department, Ms. Olivia Flores and Ms. Aidee Villa concerning a public health complaint and follow up inspection at their residence identified as BLK G SEC 127 WTRR CO TOWN & COUNTRY ESTATES W/2 W/2 TR 82 to determine why the owners of the location have not been able to clean up the excess trash and garbage stored in plastic bags stacked behind the mobile home in a timely manner. Discuss, consider and/or take action on next step to have property cleaned and meet Health Department requirements.
 - Zack Holbrooks, Public Health Department stated the properties have been cleaned up and at this time the trash was on flatbed trailers to be hauled off. He stated he was satisfied with the outcome of the cleanup. Judge Therwhanger stated she had suggested the tenants purchase dumpsters for their property and they are in the process of purchasing dumpsters.
- 6. Discuss, consider and/or take action to approve the lease agreement with the South Plains Health Department.

Commissioner Houston made a motion to approve the lease agreement with South Plains Health Department, stating there are no changes at this time in the lease. Commissioner Elder seconded the motion. Motion carried unanimously. (see attached)

7. Discuss, consider and/or take action to approve renewing an Interlocal Agreement with the City of Seminole to use Gaines County ROW in Precinct 3 to bring fresh water to the water treatment plant in the City of Seminole.

Mary Furlow, Interim City Administrator stated the ROW as stated in the Interlocal Agreement was not correct and the correct ROW description is as follows:

- Proceed south on CR 323 to CR 308
- Go east on CR 308 to CR 315
- Proceed north on CR 315 to CR 304
- Turn east on CR 304 and continue to City Well Field
- The County requires a minimum of 4 foot as the required burial depth.
- Caliche and asphalt roads are to be bored

Commissioner Murphree made a motion to approve the Interlocal Agreement with the City of Seminole with corrections to the ROW description. Commissioner Rosson seconded the motion. Motion carried unanimously. (see attached)

8. Wayne Gondeck with DRG Architects will present the evaluation of the contractors submitting a bid on the Emergency Operations Center project. Take action as appropriate on project bids.

Wayne Gondeck, DRG Architects presented the evaluations of the following contractor bids presented in the February 15, 2023 commissioner's court: First Choice Construction, Oprex Construction, Seminole Home Improvements & Henthorn Commercial Construction. The Commissioners stated the roof was in very bad shape, the price of each was a high cost and the possibility of building a new EOC building. Following much discussion Commissioner Elder made a motion to authorize DRG Architects to discuss the best value for the EOC project with Henthorn Commercial Construction and present to commissioner court his findings. Commissioner Rosson seconded the motion. Motion carried unanimously. (see attached)

9. Discuss, consider and/or take action for Scott Nichols to post an open position in the Parks and Golf Course Department prior to the retirement of a current employee.

Judge Therwhanger stated the position could not be filled until the employee had retired as there would be no fulltime position available until that time. Scott Nichols, stated he would hire the individual for part time summer help, which is in the budget, so that he could start a process of training the individual until the current employee retires. Judge Therwhanger stated she is meeting with TxDot regarding the postal mailbox issues within the county.

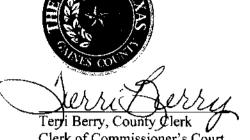
Philip Mack Furlow, District Attorney, stated he will be presenting his budget early to commissioners court as to prepare them for upcoming changes in various items

Commissioner Elder made a motion to approved the Library's Annual Report as presented by Michael Lord, Treasurer. Commissioner Houston seconded the motion. Motion carried unanimously. (see attached)

11. Discuss, consider and/or take action to receive report from Perdue Brandon for county fees and fines.

Jonathan Galley, Perdue Brandon, presented an overall report of payments, mail outs & disposed cases for JP 1 & JP 2 court. He stated this there no cost to the county for this service. Commissioner Elder made a motion to approve the report from Perdue Brandon as presented. Commissioner Rosson seconded the motion. Motion carried unanimously. (see attached)

12. Discuss and consider possible action on cost proposal from Henthorn Construction for the Emergency Operations Center building renovation.

Wayne Gondeck, DRG Architects, stated after reviewing the cost proposal from Henthorn Construction he did not recommend moving forward. He stated this would not be the best value contractor for the EOC building renovation. Commissioner Murphree made a motion to reject the cost proposal from Henthorn Construction and possibly got out for bids at another date. Commissioner Elder seconded the motion. Motion carried unanimously. (see attached)

13. Discuss, consider and/or act on directing DRG Architects to develop alternate building design for Emergency Operations Center.

Wayne Gondeck, DRG Architects, suggested a 30x60 metal building with plans submitted to court. He stated this would be a more cost effective solution to the EOC building issue with the approximate cost of \$540,000.00. Commissioner Elder stated it would be more cost effective to use local contractors to build the EOC building. Wayne Gondeck stated he would allow the court to use the plans he presented to contractors if need be. Commissioner Houston stated he wanted to replace and put up a fence at Haley Park.

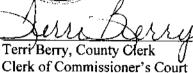
Esmeralda Felan, Auditor, stated she would be contacting Gayle Harridge, Gaines County Appraisal District to get a mineral value update.
