She stated this would be funded by hers She gave examples of projects to be done at the Center such as: cooking, quilting, sewing etc. She stated she had not yet purchased land. The Commissioners discussed the possibility of donating land to her North of town and would discuss further with her regarding this. She also stated she would be having a life size Tee Pee built regarding the connection with Mennonite heritage and Comanche Indians.
