- completed and an Interlocal Agreement has been presented to court. Commissioner Rosson seconded the motion. Motion carried unanimously. (see attached)
- Consider authorizing Texas Ranger Dominic Zuniga to utilize office 315; take action as appropriate
  - Commissioner Belt made a motion to authorize Texas Ranger Dominic Zuniga to utilize room #315 in the Courthouse. Commissioner Murphree seconded the motion. Motion carried unanimously.
- Consider allowing Sabra Hall to make policy changes concerning fines; take action as appropriate
  - Commissioner Murphree made a motion to authorize Sabra Hall, Library Director, to make policy changes for Senior Citizens to be exempt from fines at the Library. Commissioner Belt seconded the motion. Motion carried unanimously. (see attached)

Commissioner Murphree made a motion authorizing Sabra Hall to apply for the Tocker Foundation grant to replace the library software. Commissioner Rosson seconded the motion.   - D.A. Dagley, Fire Department, stated he requested assistant in purchasing a new ladder truck (approximately 1.3-1.6 million dollars) and firefighting equipment (approximately \$5,000) 5% cost to the county and 5% for the city which would be \$80,000 for the truck and \$5,000 equipment) and the grant money would pay for the remaining balance. Commissioner Houston made a motion to approve funding 5% of the cost of the truck and firefighting equipment. Commissioner Murphree seconded the motion. Motion carried unanimously.
