 - Judge Keyes called the meeting to order with a prayer and pledges of allegiance.

- 3. Discuss routine administrative items: take action as appropriate

 - 3f)Commissioner Rosson made a motion to approve the annual invoice for the library chromebooks with e-Libris Technologies, LLC in the amount of \$229.00. Commissioner Belt seconded the motion. Motion carried unanimously. (see attached)

- Commissioner Belt made a motion to approve the routine administrative items as presented. Commissioner Houston seconded the motion. Motion carried unanimously. (see attached)
- 4. Meet with JSA to receive recommendations for the courthouse roof; take action as appropriate JSA representative presented results from 2 bids received from Red Oak Roofing Inc. and ABF Commercial Roofing & Foam Inc. He stated JSA recommended ABF Commercial Roofing & Foam Inc. This item was tabled to consider complications regarding cooling ventilations. Commissioner Court requested JSA to obtain a bid from their engineer as to the cost of replacing the cooling ventilation prior to the roof repair. JSA stated the bids he presented were good for 60 days and after that point bids would have to go out again.
- Meet with Shelby Concotelli and Shawntay Pettyjohn to discuss mosquito spraying and cart path boundaries for July 4 celebration; take action as appropriate
 - Shawntay Pettyjohn requested commissioner court give authorization to The Chamber of Commerce to place boundaries for golf carts during the July 2nd celebration. She also stated the need for mosquito spraying during the celebration. Judge Keyes stated Scott Nichols would be in charge of spraying for mosquitos. Commissioner Murphree made a motion for the golf cart boundaries to only access the golf course area and to deny access to the road east to west in the back of the golf course. Commissioner Belt seconded the motion. Motion carried unanimously.

 - This item was tabled until Sabra Hall, Library Director, could be in attendance.

Consider rate change for Gaines County health insurance for 2023; take action as appropriate Michael Lord, Treasurer, stated there had not been an increase in rates for past 2 years however, the increase in the insurance for 2023 is 6.5% which is \$58.14 increase per employee. Commissioner Houston made a motion to approve the health insurance rate change for 2023. Commissioner Murphree seconded the motion. Motion carried unanimously. (see attached)

Commissioner Murphree made a motion to authorize Esmeralda Felan, Auditor, to issue a credit card to Scott Nichols, Golf Course Superintendent to purchase items online for the Golf Course. Commissioner Houston seconded the motion. Motion carried unanimously. (see attached)

6. Consider authorizing County Auditor to issue credit cards for sheriff's office employee's to allow them to conduct county business; take action as appropriate

Commissioner Houston made a motion to authorize Esmeralda Felan, Auditor, to issue credit cards to the following sheriff office employees: Chief Deputy Landon Walker, Lieutenant Joe Vest, Sergeant Victor Montez, Sergeant Luis Luis and Sergeant James Everett to conduct county husiness. Commissioner Rosson seconded the motion. Motion carried unanimously. (see attached)

7. Meet with Gaines County Library Staff to consider a potential change in library policy on who can be issued a library card; take action as appropriate

Sabra Hall, Library Director, stated the library is out of compliance with the current rules regarding ID's required and rules regarding who can be issued a library card. She stated she has amended the current policy stating the proper ID required and the requirement to live in Gaines County. Commissioner Rosson made a motion to approve the library policy changes as presented. Commissioner Belt seconded the motion. Motion carried unanimously. (see attached)

8. Consider authorizing the County Judge to contract for asbestos testing in and around the old library in Seagraves and if necessary contract for abatement in preparation for renovations to convert the space into a courtroom for Pct. 2 Justice of the Peace; take action as appropriate

Commissioner Rosson made a motion to authorize Judge Keyes to contract for asbestos testing in and around the old library in Seagraves and contract for abatement to prepare for the space to become the courtroom for Precinct 2 JP. Commissioner Belt seconded the motion. Motion carried unanimously.

Discuss identifying the doors of the county buildings for First Responder access; take action as appropriate

Commissioner Murphree made a motion to place #'s on doors to clearly identify to Emergency/First Responder personnel the correct door to enter. Commissioner Rosson seconded the motion. Motion carried unanimously.

10. Consider awarding bid for courthouse roof; take action as appropriate

Judge Keyes stated at the last commissioner court meeting it was determined that a vent was needed installed before the roof repair. He stated since then he has been informed this is no longer needed to continue with the roof repair. Commissioner Belt made a motion to accept the bid for the roof repair from ABF Roofing and Foam in the amount of \$391,528.00. Commissioner Rosson seconded the motion. Motion carried unanimously. (See attached)

11. Consider approving appointment of a board member for the North East Gaines Emergency Services District; take action as appropriate

Following discussion all commissioners voted unanimously to appoint Teresa Freeman as a board member for the North East Gaines Emergency Services District.

12. Consider accepting a donation of 10 acres on land attached to the Unical calche pit from the Sparks Ranch; take action as appropriate

Commissioner Murphree stated he was contacted by Trina Sparks, Sparks Ranch, to donate 10 acres of land at the Unical calche pit for 150 loads of caliche and they will deed the SE corner of the SW/4 of Section 364 to the county. Commissioner Murphree made a motion to accept the donation from Sparks Ranch as presented. Commissioner Houston seconded the motion. Motion carried unanimously. (see attached)

13. Consider approving the use of the Gaines County Park for a wedding ceremony; take action as appropriate

Commissioner Rosson made a motion to approve the request for a wedding to be held at the Gaines County Park July 30th. Commissioner Belt seconded the motion. Motion carried unanimously.

14. Consider all available options including going out for a Request for Proposal for a Gaines County Public Defender Office, due to Artie Aguilar's termination of his contract with Gaines County to provide indigent defense in the 106th District Court for Gaines County defendants; take action as appropriate

Following much discussion this item was table until further research and information can be obtained from Judge Keyes and presented to Commissioners court.

15. Consider approving subdivision application(s), take note of known exceptions, consider any requests for variances; take action as appropriate

Judge Keyes stated the Bustos law firm was finalizing the Subdivision policy and would present it at the July 6th Commissioners court meeting. Judge Keyes stated he had been contacted by someone stating they had an approved subdivision and was now wanting to also subdivide the back part of the property. This item will be researched in reference to when he submitted his original subdivision and a possible variance being done.

16. Consider current road crossing request(s); take action as appropriate

Esmeralda Felan, Auditor, stated the county has received the 2nd payment from the American Rescue Plan.

Commissioner Houston stated on CR 422 in Precinct 4 an oil company had abandoned the caliche pad and the oil company gave him permission to haul the caliche off.

Commissioner Rossen stated the first ball game at the field in Seagraves, after the new rules were implemented had resulted in the field being cleaned and there were no negative issues.

Commissioner Belt stated he was pricing the fencing to be placed at Lytle Field.

Judge Keyes stated he and Commissioner Houston were to meet with Kevin PettY regarding Indio Field and possibility more land being made available.

Judge Keyes stated himself, Robert Barrett, Kyle Abbott, Ronnie Pipkin and Scott Shortes were to have a conference call with Tower Construction Company.

All budget requests were approved (Commissioner Murphree abstained from voting on the District Clerk budget request) with the following changes:

Auditor: Conversion Financial System Software in the amount of \$150,000.00 will be added in the budget line.

JP 1: Commissioners requested an explanation of the \$4,995.00 change in Capital Equipment Purchase

Sheriff: Capital purchase in the amount of \$120,495.00 and non-capital equipment purchase in the amount of \$29,495.00 was approved to be paid now out of the American Rescue Plan fund.

Civil Defense: Communication Supplies (batteries) in the amount of \$795.00 was approved to be paid now out of the American Rescue Plan fund.

Seagraves Senior Citizens: Capital Equipment purchase in the amount of \$17,995.00 was approved to be paid now out of the American Rescue Plan fund.

All Precincts: Any equipment that is needing replaced or purchased was approved to do do so now and be paid out of the American Rescue Plan fund.

Golf Course: Capital Equipment purchase in the amount of \$54,995.00 was approved to be paid now out of the American Rescue Plan fund.

Raises of 6% was approved for all employees except for Sheriff Department staff who will receive a higher percent raise once a survey is conducted of other counties by Michael Lord, Treasurer and presented at the next budget workshop.

The language in the seasonal/part time policy will changed stating pay to be up to \$15 an hour.

Following discussion regarding the GSA Travel Rates in Texas as presented by Esmeralda Felan, Auditor it was approved to increase daily per diem from \$45 to \$65 for travel days.

The following changes were approved on the 2023 Holiday Schedule:
