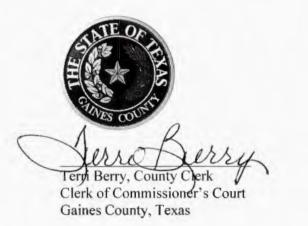

Esmeralda Felan, Auditor stated she could not give an accurate revenue amount until she receives totals from all entities. She stated after taking a census of surrounding counties that we are under the percentage of matching retirement and providing health insurance to retirees. Commissioners stated providing health insurance to retirees on this budget would not be feasible as there needs further research and a plan put in place. She also stated the national percentage of raises as of May 10th would be 4% and this could change with each month.

b) Discussion on budget requests.

Esmeralda Felan, Auditor stated that at the next commissioners court she would go further in depth with each office's budget request once she receives all totals required.
