 - D.A. Dagley, Fire Chief gave a detailed report of all activities and transactions for the Fire Department from January 1, 2024 through December 31, 2024. He stated he will email this report monthly to the county. (see attached) No action taken.

Susan Murphree, District Clerk stated she has Civil Records to be scanned and has an on site proposal from Terralogic for approximately \$100,000.00. Terri Berry, County Clerk has authorized the transfer of the funds from her Record Preservation/Archive fund to the District Clerk for this project.
