The voter-approval rate is the highest tax rate that GAINES COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that GAINES COUNTY is not proposing to increase property taxes for the 2020 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 28, 2020 at 11:30 AM at Gaines County Commissioners Court Room.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, GAINES COUNTY is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting Gaines County of GAINES COUNTY at their offices or by attending the public meeting mentioned above.
