McWhorter Survey, Abstract 261, more particularly being part of the platted 4<sup>th</sup> Street, located between Block 57 and Block 96, as recorded in Volume 32, Page 100 of the Matagorda County Deed Records. Described in metes and bounds by attached Exhibit "A" consisting of 4<sup>th</sup> Street Tract 1 and 2 (labeled for purposes of this abandonment only) to this agenda request. Once abandoned, the Court further directs the County Clerk to index the order in the County Deed Records in a manner that describes the County conveying property as Grantor and Grantees receiving the conveyance as follows:
  - A. Fourth Street Tract 1 dimensions in Exhibit "A" shall vest in Block 96, Lot 6, Andrea Kocurek and Christopher Pearce
