II. GENERAL CONDITIONS

Matagorda County will receive bids up to 2:00 p.m. Thursday, October 27, 2022. **BIDS MUST BE SEALED AND MARKED** with bid number and/or title, on the outside of the envelope and be submitted on this form. The entire bid package, including the signature page must be returned with bid. Bidder may bid any or all material(s) for any location. Also, include plus or minus "per mile" rate on page 6 if applicable.

The Agreement that results from this bid award may be subject to interlocal agreements with other Matagorda County Special Districts. These entities are governed by their own Directors or Commissioners and any negotiable item(s) shall be determined by their governing board. Each entity shall be responsible for contacting the Contractor/Hauler. If the delivery is not to a county stockpile the delivery location and charges are negotiable between the entity and Contractor/Hauler. Each entity shall be billed directly and be held responsible for payments.

Commissioners shall have the right to reject, at any time, any material that is undesirable or is not suitable for either road or stockpile location.

Matagorda County legally accepts the road materials after it is unloaded and approved by Commissioners of precincts unless hauled in county trucks, at which time county accepts material when it is loaded in county trucks.

This contract shall be in effect from date of contract award until date of next award, which should be approximately 1 year.

Matagorda County reserves the right to award this bid to the responsible bidder who submitted the lowest and best bid and reserves the right to accept the next lowest bidder as an alternate bid in case awarded bidder cannot meet delivery schedule. Low bidder shall be contacted first for each job and alternate bidder can only be used if low bidder cannot deliver. Matagorda County reserves the right to reject all bids and publish a new notice.

Terms are net payment at regular county payment dates upon rendering of invoices and provided all conditions of this bid have been met. Matagorda County reserves the right to withhold 10% of payment until completion of project when the project exceeds \$50,000.00.

INSURANCE REQUIREMENTS

The Contractor/Hauler shall not commence work under this contract until all insurance required of the Contractor/Hauler by this agreement has been documented with a Certificate of Insurance. Such insurance is to be provided at the expense of the Contractor/Hauler and shall remain in force until all work under this contract is completed and has been accepted by the County Commissioners'. In the event an insurance policy required by this contract expires during the performance of this contract, the Contractor/Hauler shall provide confirmation that coverage will be continued without interruption. This confirmation must be provided prior to the date that the insurance coverage was to have otherwise expired.

The Contractor/Hauler shall include all subcontractors as insured under its policies or shall furnish separate certificates of insurance and endorsements for each subcontractor. All coverage's for subcontractors shall be subject to all of the requirements under this contract. Nothing contained in

the insurance requirements shall be construed as limiting the extent of Contractors/Haulers responsibility for payment of damages resulting from operations under this contract.

Any failure of the Contractor/Hauler to comply with the reporting provisions of the insurance policies shall not affect the coverage provided to Matagorda County.

The insurance provided by the Contractor/Hauler shall be primary as respects Matagorda County. Any insurance maintained by the County shall be excess of the Contractor's/Hauler's insurance and shall not contribute to it. Further, the Contractor's/Hauler's insurance must include a waiver of subrogation in favor of the County. The Contractor's/Hauler's insurance shall not have deductibles of self-insured retentions in excess of \$25,000 per occurrence.

The Contractor/Hauler must provide confirmation of Commercial General Liability insurance from an insurer licensed to do business in Texas that is financially sound. The insurance should be written with limits of a least \$500,000 per occurrence and an aggregate limit of at least \$1,000,000. The insurance must include coverage for bodily injury, property damage, contractual liability, products and completed operations, and personal injury. The Contractor's/Hauler's insurance policy must include Matagorda County, its officials and employees as additional insured's' for occurrences arising out of the performance of this contract. The confirmation should indicate that this specific contract (or "all written agreements") is an "insured contract" for purposes of contractual liability insurance. The Contractor/Hauler must promptly notify the County Commissioners if the total incurred losses (as determined by the insurer) reaches 50% or more of the aggregate limit. The County Commissioners should be provided with 30 days advance notice of material changes in coverage or termination of coverage.

The Contractor/Hauler subcontractors and their employees are not to be considered as an "employee" of the County and will not be covered by the County's workers' compensation insurance. The Contractor/Hauler must provide confirmation of Workers' Compensation and Employer's Liability insurance from an insurer that is licensed to do business in Texas if the Contractor/Hauler is subject to the Workers' Compensation Statute. The Workers' Compensation insurance should be written with statutory limits of liability. The Employer's Liability insurance should be written with limits of at least \$500,000 each employee for occupational disease. The County Commissioners should be provided with 30 days advance notice of material changes in coverage or termination of coverage.

The Contractor/Hauler must provide confirmation of Commercial Automobile Liability insurance from an insurer that is licensed to do business in Texas. The insurance should be written with bodily injury and property damage limits of at least \$500,000 combined and should apply in regard to any automobile, including owned, non-owned, hired and borrowed automobiles. The County Commissioners should be provided with a 30 day advance notice of material changes in coverage or termination of coverage.

The Contractor/Hauler must indemnify, hold harmless and defend Matagorda County and its officials and employees for all claims, demands, payments, suits, actions, proceedings, and judgments of every nature and description (including attorney's fees) that are presented, brought or recovered against Matagorda County and/or its officials and employees which arise out of an occurrence in connection with the services performed under this contract, except for liability stemming from the County's sole negligence. Matagorda County reserves the right to require the Contractor/Hauler to provide complete, certified copies of all required policies at any time.

III. BID CONDITIONS AND SPECIFICATIONS

- 1. Bid shall be on delivered basis or on point of pickup when County owned trucks are used.
- Materials shall be delivered to job site in Matagorda County as directed by Commissioner of applicable precinct. Job site can be road, field location, or stockpile at designated location. Miles from pit to stockpile will be shortest legal route.
- 3. Material bids must be broken down into price per ton and delivery price. The sum total of these will be used to determine the lowest and best bid.
- 4. A fuel adjustment will be allowed on the **delivery price only** as fluctuations in diesel prices occur as listed on http://www.eia.gov/petroleum/gasdiesel/ using the Gulf Coast region. The baseline price will be the price on this site on December 5, 2022 rounded to the nearest one-hundredth and **thereafter the index will be adjusted and documented on Monday of each week after bids are accepted.**
- 5. The allowable fuel adjustment will be calculated by subtracting the baseline price from the posted price (for the Monday immediately prior to the delivery date of the material), and if the difference is <5 cents, no adjustment; 5 cents to 9 cents, 1% adjustment to the delivery price per ton; 10 cents to 14 cents, 2% adjustment to the delivery price per ton and so on. A 1% adjustment will be made on the delivery price for every 5 cent increase or decrease from the baseline price.
- 6. Delivery of material to any location other than a stockpile will be invoiced at the nearest stockpile rate, **plus or minus the "per mile" rate quoted on this bid form**. Any "plus or minus" mileage will be agreed upon by the bidder and the Commissioner of that precinct. There will be no fuel adjustment calculated on the plus or minus mileage.
- 7. Materials shall be ordered in quantities as determined by each Commissioner.

- 8. Precincts will accept the number of trucks necessary to do job on a most cost efficient basis, which could require various numbers of trucks.
- 9. Precincts will supervise the dumping of loads.
- 10. Precincts will put out needed signs and barricades for traffic control.
- 11. Each load shall be weighed on a certified public scale. Truck and trailer shall be weighed empty at least once on each job run, or when a change is made due to changing truck, trailer, or other. Cost of weighing shall be paid by hauler. Driver shall get a material company ticket from pit or location when loading. A copy of the scale weight ticket, material company ticket and company delivery ticket shall be given to the county employee at job when load is inspected and dumped.
- 12. Matagorda County shall have the right to pull sample loaded truck(s) to a certified scale of County's choice for loaded weight, unload truck(s) and take empty weight on same scale to verify weights. County shall pay for the weighing.
- 13. Upon initial contact, accepted bidder shall advise at that time if required delivery schedule can be met. Cooperation and coordination between Commissioners and bidder is essential to make contract work. Commissioner has the right to stop hauling at anytime due to weather, road conditions and machinery breakdowns.
- 14. Bidder must be able to furnish bid items under terms of these specifications if bidder is awarded bid.
- 15. Item number and material description, as stated on this bid specification <u>must</u> appear on all invoices in order to be considered for payment.
