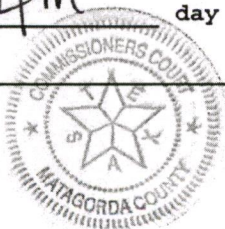
And we, and each of us, further certify that we actually and fully inspected the Treasurer's Report, See Exhibit "A", on this the 11th day of September, 2024.
