

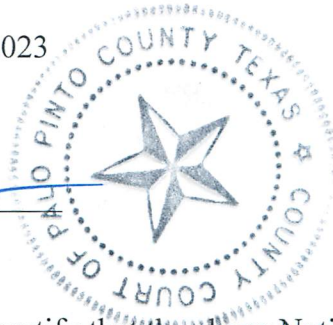
**NOTICE OF REGULAR MEETING**


