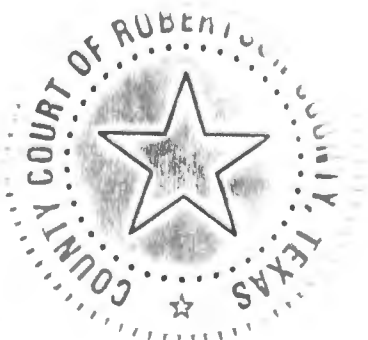

This meeting will be held in the County Courtroom on the third floor of the Robertson County Historic Courthouse, 102 E Decherd St. Franklin, Texas. A **proposed budget is on file in the Robertson County Clerk's Office and on Robertson County's website for public inspection.** This budget will raise more revenue from property taxes than last year's budget by an amount of \$1,133,048.00 or 6.51 percent. The property tax revenue to be raised from new property added to the tax roll this year is \$374,914.00.
