**ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT**

At a regular meeting of the Commissioners' Court of Runnels County, Texas, held on the 10<sup>th</sup> day of November 2020, the following order was adopted:

NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Runnels County, Texas, that such Treasurer's Report for the month ended October 31, 2020 be and hereby is, approved and accepted as correct.
