

# Coleman County, Texas

### ADOPTED BUDGET

This budget will raise more total property taxes than last year's budget by \$428,796.31 or 10.56%, and of that amount \$85,408.52 is tax revenue to be raised from new property added to the tax roll this year.

In presenting this budget to the Commissioners Court and to the taxpayers of Coleman County, the following statistics are set out:

Estimated Assessed Valuation \$ 556,134,181.00

Total assessed valuation in Coleman County for 2023 is based on approximately 100% of the true or market value of property assessed.

Proposed county tax levy contained in the budget per \$100 of assessed valuation \$ 0.8227

The total amount of county taxes levied for this budget based on the above assessed valuation and tax levy is \$4,674,047.11. Of this total amount it is estimated that 96% or \$4,487,085.22 will be collected within the current year and that approximately \$186,961.89 of said total taxes will probably be delinquent on September 30, 2024.

Estimated to be collected during current year \$ 70,000.00

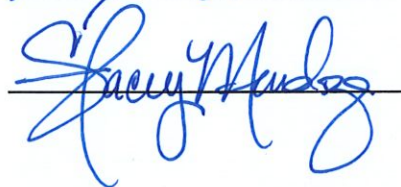

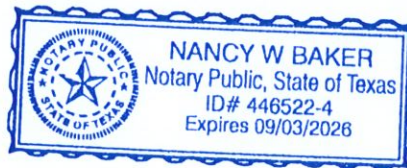
