Attached for your consideration is the proposed budget for Regular Funds and Special Funds for Concho County for Fiscal Year 2008 which begins October 1, 2007 and ends September 30, 2008.

Our receipts in Regular Funds will be realized through the estimated ad valorem tax rate of \$0.499543 cents per \$100 assessed valuation for General Fund and the estimated ad valorem tax rate of \$0.094234 cents per \$100 assessed valuation for Special Road and Bridge Fund for a total of \$1,342,831. The other \$1,470,492.00 in our estimated Regular Funds receipts will come from fund balances, state payments, reimbursements and grant monies. We anticipate total expenditures in Regular Funds of \$2,462,684.00.

Our estimated receipts in Special Funds will be \$209,893.00 and will come from fund balances, court fees, reimbursements and local sources. We anticipate total expenditures in Special Funds of \$146,794.00. The balance will come from fund balances.

The certified tax valuation for General Fund is \$226,410.500.00 and the certified tax valuation for Special Road and Bridge is \$224,320,430.00.

This budget will raise more total property taxes than last year's budget by \$5,524.00 or .4%, and of that amount, \$361.00 is tax revenue to be raised from new property added to the tax roll this year.

In the following pages you will find the proposed budgets for Regular Funds and Special Funds; shown in detail with a comparison of adopted expenditures for FY2006, FY2007 and proposed expenditures for FY2008. You will also find pages with itemized list of revenues.

The budget committee will be happy to answer any questions you may have concerning the proposed FY2008 budget.
