

The total amount of county debt obligations are: \$2,371,700
This budget will raise more revenue from property taxes than last year's budget by an amount of \$\\$139,192\$, which is \$\\$.6290\$ percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$\\$7,831\$.
