

**SUMMARY AND CERTIFICATION OF POST-ELECTION HAND COUNT AUDIT RESULTS**

I, the undersigned, General Custodian of Election Records for the Joint Primary Election, held on the 3<sup>rd</sup> day of March, 2026, in Colorado County, Texas, do hereby certify that the following is a comparison total of all votes received by each candidate and votes received "for" and "against" each measure as tabulated by the voting system equipment to the total votes as tabulated by the Post-Election Hand Count Audit at the following polling locations and precincts. The Post-Election Hand Count Audit was completed and concluded on 9<sup>th</sup> day of March, 2026. I further certify that the comparison includes the results for early voting in person, election day voting in person, and ballots by mail received under Section 87.1231 of the Texas Election Code.

Colorado County still reports results by precinct, but the manual count requirement is based on the voting location. This creates complications during Early Voting count because we operate three separate EV locations, yet the tabulation system produces one combined Early Voting total. All three boxes must be manually counted, but the total we are supposed to reconcile against isn't known until the final box is completed.

Once each box is counted, it is immediately resealed. If a manual counting error occurs in one of the earlier boxes, it becomes impossible to go back and identify or correct the discrepancy. In this election, Early Voting produced a total of 2,429 ballots, with the majority cast at the main Early Voting site, which further increases the complexity of ensuring accurate reconciliation.

Colorado County paid the counting board for 16 hours of work to complete the manual ballot count. This total does not include the additional time that would have been required to go back and locate discrepancies in the manual count. In fact, eight hours of work was not enough to even finish counting the Early Voting ballots alone.

Given the volume of ballots and the complexity of the process, it is not cost-effective for the county to spend additional hours trying to resolve discrepancies that can be reasonably attributed to human error or that can be clearly explained based on how the mistake occurred.




