TO: THE QUALIFIED VOTERS OF COLORADO COUNTY, TEXAS:

Colorado County Commissioners Court has issued an Order calling for an election to be held on May 3, 2025, from 7:00 A.M., to 7:00 P.M., at which election all eligible voters residing within the boundaries of proposed COLORADO COUNTY EMERGENCY SERVICES DISTRICT NO. 1 will be entitled to vote on the following:

Proposition A:

"CONFIRMATION OF THE CREATION OF COLORADO COUNTY EMERGENCY SERVICES DISTRICT NO. 1 AND THE LEVY BY THE DISTRICT OF A TAX NOT TO EXCEED TEN CENTS (\$.10) ON THE ONE HUNDRED DOLLARS (\$100.00) OF VALUATION."

(b) Early voting by personal appearance at the Main Early Voting polling place and Branch Early Voting polling places shall be conducted on the following days and hours:


