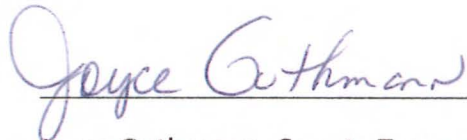

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for July 31, 2024, is \$28,731,592.57.

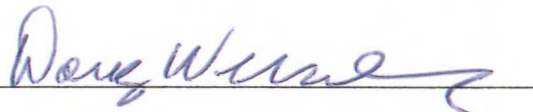
