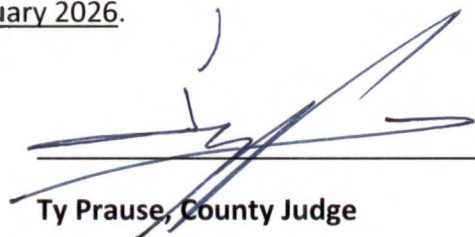

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for November 30, 2025, is \$19,506,846.57.

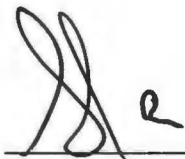

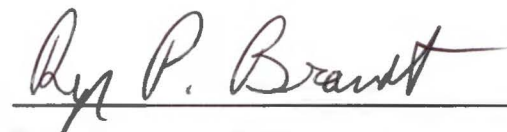

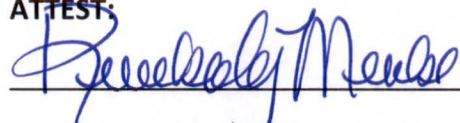
