THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for JUNE 30, 2019 is \$16,144,235.21

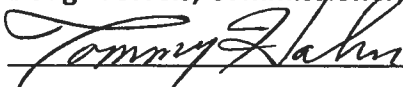
