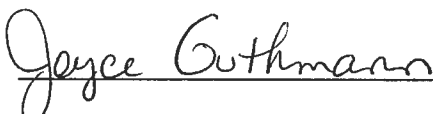

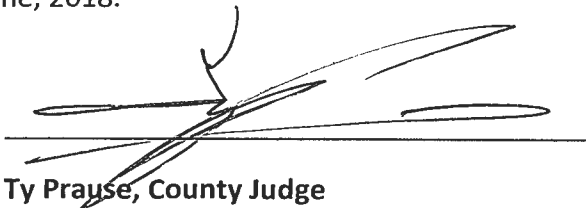

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for MAY 31, 2018 is \$15,554,277.44

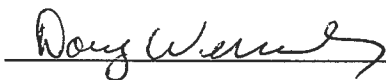
