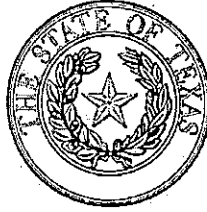

Judge stated he will meet with Toby Yaklin regarding a notice published in the Kingsville Record concerning the potential sale of the water supply. South Texas Water Authority (STWA) will conduct research with Grant Works, as STWA has invested funds in the project and is unsure whether such a sale is permissible. Questions were raised regarding where the proceeds would go if the water supply were sold.

The County is working with Texas A&M University–Kingsville (TAMUK), which has hired a new Dean of Nursing, making the university eligible to apply for a \$19,000 grant. The School of Nursing could be constructed at the Oxy site and may also serve as an emergency shelter if needed. The grant application process opens on October 9, 2025.

Commissioner Schultz commended the Treasurer’s Office and the Auditor’s Office for their assistance in making it possible to obtain a new generator after the generator at the airport stopped working.
