**"CONSIDER AND TAKE APPROPRIATE ACTION ON A RESOLUTION AND ORDER AUTHORIZING THE COUNTY TO ENTER A TAX ABATEMENT AGREEMENT PURSUANT TO THE COUNTY'S GUIDELINES AND CRITERIA UNDER THE PROPERTY REDEVELOPMENT AND TAX ABATEMENT ACT, CHAPTER 312 OF THE TEXAS TAX CODE AS REQUESTED BY MOCKINGBIRD SOLAR CENTER, LLC FOR APPROXIMATELY \$406,500,000 IN IMPROVEMENTS RELATED TO THE GENERATION OF ENERGY UTILIZING SOLAR PANELS. THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT IS LOCATED ON LAND OWNED BY LAMAR RANCH, LTD WITHIN THE MOCKINGBIRD SOLAR REINVESTMENT ZONE NUMBER 3 LOCATED IN PRECINCTS 2 AND 3 AND COMPRISSES APPROXIMATELY 9,500 ACRES AND IS LOCATED NORTH AND WEST OF BROOKSTON AND IS BOUNDED TO THE WEST BY COUNTY ROAD 34050 AND TO THE EAST BY FARM TO MARKET ROAD 38, ALONG US HIGHWAY 82, AND BOUNDED TO THE SOUTH BY FARM TO MARKET ROAD 1509 IN WESTERN LAMAR COUNTY.
