

## REQUEST FOR BID

THE COMMISSIONER'S COURT OF LAMAR COUNTY WILL RECEIVE BIDS UNTIL 10:00 A.M., MONDAY, JUNE 28, 2021, FOR THE PURCHASE OF REGULAR UNLEADED GASOLINE, DIESEL FUEL AND RED-DYED DIESEL FUEL. THE CONTRACT PERIOD WILL BEGIN JULY 1, 2021 AND END DECEMBER 31, 2021.

BIDDERS SHOULD STATE THE GRAVITY OF THE GASOLINE AND DIESEL FUEL. GASOLINE MUST BE REGULAR UNLEADED WITH A MINIMUM OCTANE LEVEL OF 87. BID PRICE SHOULD BE BASED ON PRICE PER GALLON. BID DATE FOR MARKET PRICE COMPARISON FOR THE BID WILL BE FRIDAY, JUNE 18<sup>TH</sup>, 2021. INCLUDE ANY ADD-ON CHARGES AS PART OF THE BID PRICE. A COPY OF THE BILL OF LADING SHOWING WHERE PURCHASED AND A MARKET PRICE PRINTOUT SHOWING MARKET PRICE PAID WILL BE REQUIRED WITH EACH PURCHASE OF GASOLINE OR DIESEL. LIST PRICES FOR A BOB-TAIL, TRANSPORT LOAD, OR ANY PARTIAL LOAD. THE LAMAR COUNTY SHERIFF'S DEPARTMENT, EMERGENCY MANAGEMENT, CONSTABLES, THE COUNTY ATTORNEY INVESTIGATOR, AND PRECINCT THREE AND FOUR COMMISSIONERS WILL ALSO RECEIVE BIDS FOR VEHICLE PURCHASES AT PUMP SITE ON A 24-HOUR BASIS. LAMAR COUNTY IS A TAX-EXEMPT ENTITY.

THE COMMISSIONER'S COURT RESERVES THE RIGHT TO REJECT ANY OR ALL BIDS AND TO WAIVE MINOR TECHNICALITIES.
