The data includes identifying and recording information on pedestrian and motor vehicle traffic stops that this agency encounters daily.

This is a comprehensive report of the racial profiling law, its regulations and the policies incorporated by the Lamar County Sheriff's Office pursuant to the law change. Information incorporated also includes traffic stops and search information, Uniform Crime Reporting records, and various data of County demographics, department makeup, and vehicle equipment designed to meet the racial profiling requirements.

**REPORT ON COMPLAINTS OF RACIAL PROFILING**  
**AGAINST OFFICERS - 2025**

**There was no racial profiling complaints made against Lamar County Sheriff Deputies for the reporting year 2025. This continues to signify the professionalism that Lamar County Deputies hold true to their profession, and to the service of the citizens of Lamar County. The Lamar County Sheriff's Office under the leadership of Sheriff Scott Cass strives in the promotion of honesty, integrity, and service to the community in which it serves. Citizen relationships and community service are top priorities as well as the safety of the citizens that fall under its jurisdiction.**

**This agency responded to and/or initiated 24,433 calls for service, affected 998 arrests, and conducted 2938 traffic stops, including citations and/or warnings issued. This agency has a large responsibility in all Court-Ordered Mental Health services for the County of Lamar and the City of Paris and the transportation thereof. The Sheriff's Office also transports juveniles pursuant to proceedings of the Lamar County Juvenile Court, warrant arrests/transfers, a civil process division, maintains a 196-bed jail facility, and all other Constitutional and Statutory duties of the Office of Sheriff. This Office strives for continued progress in all facets and diversities in the service to the citizens of Lamar County, Texas.**

**The Sheriff's Office has complied with all Racial Profiling requirements mandated by SB 1074, including, TCOLE mandated training and education for all Lamar County Deputies on staff. Racial Profiling complaint forms are available at any time from the Records Division of the Sheriff's Office, and or from any Officer of the Lamar County Sheriff's Office.**
