To the registered voters of the County of LAMAR, Texas:

Notice is hereby given that the polling places listed below will be open from 7:00 a.m. to 7:00 p.m., March 3, 2026, for voting in a joint general primary election for the Democratic and Republican Parties to nominate federal officers, Members of the State legislature, and state, district, county and precinct officers; and for the purpose of electing county and precinct chairs.

On Election Day, voters must vote in the precinct where they are registered to vote.




