BRIEF NARRATIVE: On 11/09/2018 at about 1619, Capt. Moore responded to a report of loose livestock in the 3000 block of FM 137. The loose livestock, eight (8) miniature donkeys, were placed in a fenced lot on Jim Lester's property, 3477 FM 137, until an owner could be located.

On 11/14/2018, Capt. Moore told me that the owner of the donkeys had not been located and Johnny Newman was going to load the donkeys and transport them to impound them at about 1500. I went to the location and observed two men loading hay onto a trailer a few hundred yards down the road. I asked if they knew who the donkeys belonged to. I was told they possibly belonged to a Wayne Snelling. Dispatch left a voice mail message at his listed number. I had Dep. Hill go to Snelling's listed address, 583 CR 44140, to attempt to make contact. Dep. Hill advised that no one was at the residence. I met Newman and several men he brought to help load the donkeys. The donkeys were loaded and transported to Cattlemen's Livestock Commission, 1354 Clement Rd., Paris, TX.
