As of March 31 st	\$30,247,460.08

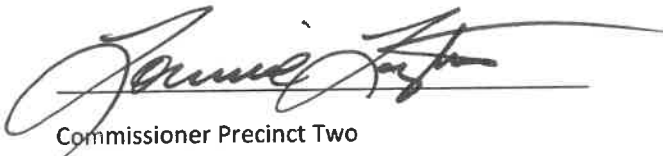

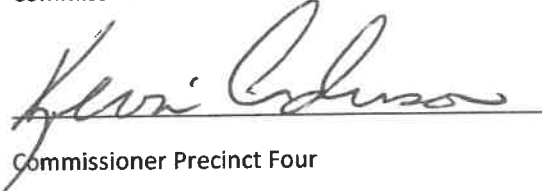
Commissioner Precinct One



Commissioner Precinct Two



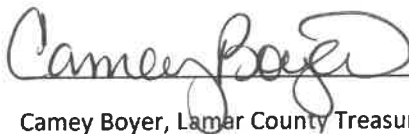

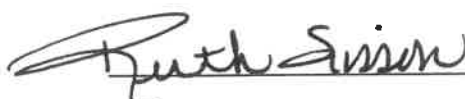
