This individual will play a critical role in helping our criminal clients access the mental health, addiction treatment, and housing services they need to reintegrate into society. The social worker will also work closely with legal teams, community organizations, and treatment providers to build and implement an effective service program that directly supports the defense and long-term success of criminal defendants.

Key Responsibilities:

- **Leadership:** Provide guidance to four case managers responsible for helping criminal defendants navigate mental health, addiction treatment, and housing options.
- **Program Development:** Lead the design, development, and implementation of a comprehensive service program that addresses the needs of clients with mental health and substance abuse disorders, ensuring that they have access to appropriate resources, treatment programs, and housing placements.
- **Client Support & Advocacy:** Act as a primary resource and advocate for clients, ensuring they receive the treatment and services necessary for rehabilitation. Work with clients to create individualized plans for treatment and recovery.
- **Collaboration with Legal Teams:** Work closely with attorneys to ensure that clients' treatment and service needs are factored into *defense strategies*. Assist in gathering evidence of treatment efforts to support case outcomes.
- **Case Management:** Oversee the coordination of care and resources, ensuring that case managers are providing comprehensive, timely, and effective services. Assist in managing complex or high-risk cases directly.

- **Partnership Building:** Build and maintain strong relationships with local treatment providers, mental health professionals, addiction counselors, housing authorities, and other community organizations to ensure seamless access to services for clients.
- **Documentation & Reporting:** Maintain accurate and thorough case files, including service plans, progress notes, and documentation of client outcomes. Provide regular reports to management regarding program effectiveness and client progress.
