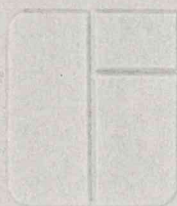


We were engaged to audit the accompanying Balance Sheet and the Statement of Revenues, Expenditures and Changes in Fund Balance of the Sheriff's Department Confiscated Funds of the Maverick County, Texas (the "County") as of and for the years ended September 30, 2010, 2011, and 2012. The financial statements were lifted from the County's annual financial statements issued in prior years and omits notes to the financial statements that may be an integral part of the financial statements. The Maverick County's annual financial statements were audited by another certified public accounting firm. These financial statements are the responsibility of the County's management.

The County Sheriff's department did not maintain a general ledger nor other records adequate to conduct an audit of the Confiscated Funds in accordance with generally accepted auditing standards or a program specific audit of the equitable sharing federal program in accordance with governmental auditing standards.

Since the County's accounting records for the Sheriff's Department Confiscated Funds are inadequate, and we were not able to apply auditing procedures, the scope of our work was not sufficient to enable us to express, and we do not express, any opinions on these financial statements.

We noted certain matters which we have reported to management of the County's Sheriff Department in a separate letter dated February 2, 2016.

We were engaged for the purpose of forming an opinion on the financial statements referred above. The Supplemental Information on pages 4 through 8 is presented for the purpose of additional analysis and is not a required part of the financial statements. Because of the significance of the matters discussed above, it is inappropriate to and we do not express an opinion on the Supplemental Information on pages 4 through 8.
