Job Title: DRUG TESTING TECHNICIAN (MALE) FLSA STATUS: NON-EXEMPT

ESSENTIAL DUTIES and RESPONSIBILITIES:

- Conducts supervised and observed urine and oral fluid collections from male clients as requested;
- Monitors and detects any potential device or substance used to interfere with the drug test during collection of the sample;
- Follows standard operating procedures and protocols for conducting test;
- Maintains detailed and accurate logs and chain of custody;
- Sorts, verifies, prepares and packages the collections for daily pick up;
- Logs and prepares UA samples for daily pick up;
- Helps maintain and inventories drug testing supplies;
- Conducts drug tests and interprets results;
- Records, disseminates, and documents test results accurately and in a timely manner;
- Reports any notable information to the probation officer or supervisor;
- Builds and maintains positive working relationships with clients, labs, agencies, and other units of the criminal justice system who come into contact with the CSCD department.
- Maintains strict confidentiality of all department records and information;
- Communicates effectively orally and in writing;
- Prepares and maintains drug testing areas;
- Disposes of used drug testing equipment/materials safely;
- Maintains a clean and sanitary work space at all times;
- Provides courtroom testimony as needed;
- · Accounts for office equipment and furniture, such as computers, monitors, desks, chairs, bookcases, etc. in assigned area.

SKILLS:

- Bilingual is preferred but not required;
- Attention to detail and accuracy in recording and documenting test results;
- Strong organizational skills;
- Ability to interact professionally with a diverse group of individuals.
