JOB DESCRIPTION:

Work involves responsibility for the day-to-day operation of the jail. Work involves primary responsibility for a variety of jobs: Maintaining safety and security of the county jail and inmates, booking or releasing inmates, transportation of inmates, supervising inmate visitation, monitoring health and welfare needs of inmates, maintaining jail records, and ensuring maintenance and cleanliness of jail areas.

EXAMPLES OF TASKS PERFORMED:

- 1. Booking and release of inmates; taking necessary fingerprints, inmate information, and photographs
- 2. Searches inmates and issues jail clothing at time of placement into jail
- 3. Supervises inmate workers
- 4. Supervises secure storage of inmate property and clothing
- 5. Maintains current information in jail records and computer systems
- 6. Escorts inmates as required to outside court hearings, medical appointments, and work assignments

- 7. Prepares inmates for transport to other correctional facilities
- 8. Supervises visitation
- 9. Supervises educational programs
- 10. Inspects and authorizes release of inmate documents and property
- 11. Logs outgoing and incoming mail and money for inmates when required
- 12. Supervises maintenance and cleanliness of all jail areas daily
- 13. Makes required checks of all inmate areas to ensure inmate safety and well being
- 14. Monitors and communicates with inmates in housing areas
- 15. Performs other related work as required

REQUIREMENTS:

- 1. Must be 18 years of age
- 2. Must be a US citizen
- 3. Must have graduated high school or completed GED
- 4. Must possess a valid Texas driver's license
- 5. Must not have been convicted of a Class B misdemeanor within the last ten years
- 6. Must never have been convicted of a Class A misdemeanor or Felony
- 7. Must never have been convicted of a family violence offense of any level
- 8. Must pass required physical agility test
- 9. Must become licensed as jailer through TCOLE within one year of employment (training provided)
- 10. Ability to read and write the English language
- 11. Ability to bend, lift, grasp, climb, use fine hand-eye coordination, push and pull, and endure long periods of standing or sitting
- 12. Ability to remain calm under stress
- 13. Ability to understand and assist in solving work-related issues
- 14. Ability to respond to telephones, two-way radios, and other auditory stimulation
- 15. Ability to evaluate and interpret information and to make independent decisions

- Knowledge of modern corrections practices and methods
- Some knowledge of appropriate federal, state and local laws
- Knowledge of the basic principles of first aid
- Knowledge of interpersonal communication skills
