E. Lacroix recorded in Volume 1082, Page 271, Deed Records, Hill County, Texas;

THENCE South 59° 59' 58" West with the common line of said Benton tract and said Right of Way, passing at 266.18 feet a 5/8 inch iron rod set and capped "JRP-5959", a total distance of 276.18 feet (called 275.94 feet) to a point for corner in a called (unnamed) creek the apparent center of which bears South 59° 59' 58" West 5.95 feet, and being the South common corner of said Benton tract and a tract described in deed to C. R. Wright recorded in Volume 926, Page 436, Deed Records Hill County, Texas, from which a 5/8 inch iron rod found for the Southwest corner of said Wright tract bears South 59° 59' 58" West 145.95 feet;

THENCE South 59° 59' 58" West leaving said creek and passing at 10.00 feet a 5/8 inch iron rod set and capped "JRP-5959", a total distance of 114.09 feet to a 5/8 inch iron rod found for the Westerly common corner of said Wright tract and said Benton tract, also in the Northeasterly line of 30 foot wide Ingress Egress Easement described in Volume 546, Page 726, Deed Records, Hill County, Texas;

THENCE North 30° 01' 57" West, with the common line of said Benton tract and said ingress Egress Easement, 239.14 feet to a 5/8 inch iron rod found for the West common corner of said Benton tract and a tract described in deed to Alvin Green and Deborah Benton, recorded in Volume 1234, Page 95, Deed Records Hill County, Texas;

THENCE North 60° 00' 13" East, with the common line of said Green / Benton tract and said Benton tract, 422.10 feet to a 5/8 inch iron rod (control monument) found for the East common corner of said Green / Benton tract and said Benton tract, also being in the Westerly line of said Lacroix tract;
