

# POLICY ON INFORMATION REGARDING ACCESSIBILITY FOR PERSONS WITH DISABILITIES

The following will be posted and maintained on the County's Website and at each building where County services are provided directly to the public. In regard to Commissioners Court meetings, the applicable information will be included on the agenda posted for each meeting.

It is the intent of Ector County that its services be accessible to persons with disabilities. Depending on the County service or program involved and the nature of the person's disability, various auxiliary aides and services are available. These may include, but are not necessarily limited to: auxiliary aids and services; sign language interpretation; personal assistance; conversion of information into an alternate format; and/or regarding information aloud for a person with a disability.
