



The District Attorney's Office does not conduct investigations. Criminal investigations are handled by law enforcement agencies. Once an investigation is complete, the agency submits the case to our office for prosecution. At this point, the Intake Department, consisting of 4 attorneys, 4 paralegals, and an investigator, takes over. The paralegals and investigator ensure the case is complete, after which an attorney evaluates the evidence and the merits of the case. If we determine there is sufficient evidence to prove the case beyond a reasonable doubt, it is formally filed and prosecuted. Approximately 30% of cases received are rejected for various reasons.

#### Trial Highlights



1-11-24 Christian Escarcega was found guilty of Murder and sentenced to Life. On 10-31-21, Mr. Escarcega and a co-defendant ambushed an individual outside Stein's Bar and shot him to death. Both defendants fled the scene but were apprehended by ECSO and OPD.


1-26-24 Johnathan McKissick was found guilty of injury to a child and sentenced to 99 years in prison. On 2-27-21, the defendant was at a local motel and was captured on video smashing a child's head and throwing the child against the wall. The child was less than 2 years old.





3-1-24 Megan Lange was found guilty of Capital Murder in the death of her 11-year-old son and sentenced to life without parole. After an investigation by the Ector County SO, it was determined that the defendant intentionally starved the child for years (he weighed 44 pounds) and suffocated the child.

3-25-24 Jesus Meza was found guilty of delivery of a controlled substance and sentenced to 37 years. On 2-6-23, undercover officers purchased fentanyl from the defendant. When the defendant was arrested, he admitted to having over two thousand fentanyl pills.




#### Trial Highlights



5-7-24 Luis Reyes was found guilty of possession of a controlled substance and sentenced to 99 years. OPD responded to an individual who was unconscious. The defendant had OD'd on fentanyl. Police used Narcan to save the defendant's life. The defendant was in possession of fentanyl.

5-9-24 Jose Sarinana was found guilty of murder and sentenced to life in prison. On 12-9-21, a deceased female was found stabbed to death at a local motel. A video shows the defendant walking into the room with the victim. The defendant was carrying a backpack, which was later found to contain a bloody knife.





6-24-24 KC Childress was found guilty of aggravated sexual assault of a child and sentenced to life. On 6-24-21, the defendant sexually assaulted a 13-year-old female with Down syndrome. The defendant has prior sex offenses and is a registered sex offender.

8-8-24 Javier Arias was convicted of seven counts, including kidnapping and aggravated sexual assault, and sentenced to life. Between 4-26 and 7-25-24, the defendant kidnapped and raped several women in Ector County.




#### Trial Highlights



8-21-24 David Chavez was convicted of possession of child pornography, 25 counts and sentenced to serve 10 years on each count, for a total of 250 years. After an investigation, it was discovered that the defendant had over 300 sexually graphic images of children.

9-27-24 Richard Davis was found guilty of aggravated sexual assault of a child and sentenced to life in prison. On 10-2-19, a 12-year-old female victim came forward and told her mother the defendant sexually assaulted her on multiple occasions. The defendant was the boyfriend of the mother at the time.





10-16-24 Ernest Marquez was found guilty of Felony DWI and sentenced to 37 years in prison. OPD stopped the defendant for doing donuts in front of a DK convenience store. It was discovered that the defendant was driving a stolen vehicle and he has at least two prior DWI convictions and at least two prior felony convictions.

11-7-24 Isaiah Renteria was convicted of murder and sentenced to 60 years in prison. On 4-15-22 the defendant was involved in an altercation with the victim, a homeless man. The defendant left the area, then returned and shot the victim. Defendant claimed self-defense, which was denied by the jury.



# **Ector County Juries**

Juries are comprised of citizens within the community. Juries listen to the evidence presented in a case and decide whether or not the defendant is guilty. Their decision directly impacts justice in Ector County. We're grateful to our community members who take the time to serve on juries—it's a big responsibility but an even bigger honor! Ector County juries sent a message in 2024 that criminal activity will not be tolerated:


- 9 Life sentences were handed down
- Defendants were sentenced to over 900 years in prison
- After trial and guilty verdicts, 24 defendants were sent to prison

In addition to trial juries, citizens also serve on grand juries. Grand juries play a crucial role in the criminal justice system, acting as a safeguard between the government and individuals accused of serious crimes. In Ector County, a grand jury is composed of citizens who are tasked with reviewing evidence presented by the District Attorney's Office in felony cases. Unlike trial juries, grand juries do not determine guilt or innocence; instead, they decide whether there is enough evidence, or "probable cause," to issue an indictment and move the case forward to trial. This process ensures that charges in serious cases are not brought without careful consideration by impartial members of our community. Grand jury service is an important civic duty, and those who serve are key to maintaining a fair and just legal system.

# Pre-Trial Intervention (PTI)

The Pretrial Intervention Program (PTI) is a valuable opportunity offered by the Ector County District Attorney's Office for eligible individuals facing certain criminal charges. This program is designed to give firsttime or low-risk offenders a chance to avoid a conviction by completing specific requirements tailored to address the underlying causes of their actions. Participants may be required to attend counseling, perform community service, complete educational courses, or adhere to other conditions set forth in an agreement. Successful completion of the program can lead to the dismissal of charges, providing a fresh start and reducing the longterm consequences of a criminal record. PTI reflects the office's commitment to balancing justice with opportunities for rehabilitation and second chances, ultimately fostering a safer and more understanding community.

In 2024, the program enrolled 594 new individuals and 427 completed the program. This is a 72% success rate. Please note, that the individuals enrolled may not be the same individuals who completed the program during any given year since the program is anywhere from 6 to 12 months. 2024 PTI

# **Appellate Division**

The Appellate Division of the Ector County District Attorney's Office is responsible for safeguarding the integrity of convictions and legal proceedings. This team of experienced attorneys handles appeals filed by defendants who challenge their convictions or sentences. They review trial records, research complex legal issues, and draft persuasive briefs to present before higher courts. The division also represents the state in oral arguments when cases are heard in appellate courts. Beyond appeals, the team ensures that the law is applied consistently and supports trial prosecutors with legal research and strategy. Their work helps maintain a fair and just legal system for our community.

# **CPS** Division

The CPS (Child Protective Services) Division of the **Ector County District** Attorney's Office plays a crucial role in protecting the well-being of children in our community. This division represents CPS in court proceedings involving allegations of child abuse or neglect. The attorneys work closely with caseworkers, law enforcement, and other agencies to ensure the safety and stability of children at risk. They present evidence, advocate for appropriate interventions, and work toward outcomes that prioritize the best interests of the child, whether that means reunification with their family or seeking permanent placement through adoption. The CPS Division is dedicated to ensuring that every child in Ector County has the opportunity to grow up in a safe, nurturing environment.



### **Committed to Fiscal Responsibility**

For the past four years, the Ector County District Attorney's Office has consistently operated under budget, a testament to our commitment to fiscal responsibility and the trust taxpayers place in us to manage public funds wisely. In 2021, we underspent by 6%, followed by 10% in both 2022 and 2023, and 15% in 2024. This prudent financial stewardship allowed us to return over \$2 million to the Ector County Commissioners during the budget process, ensuring these funds could be reallocated to other vital community needs.
