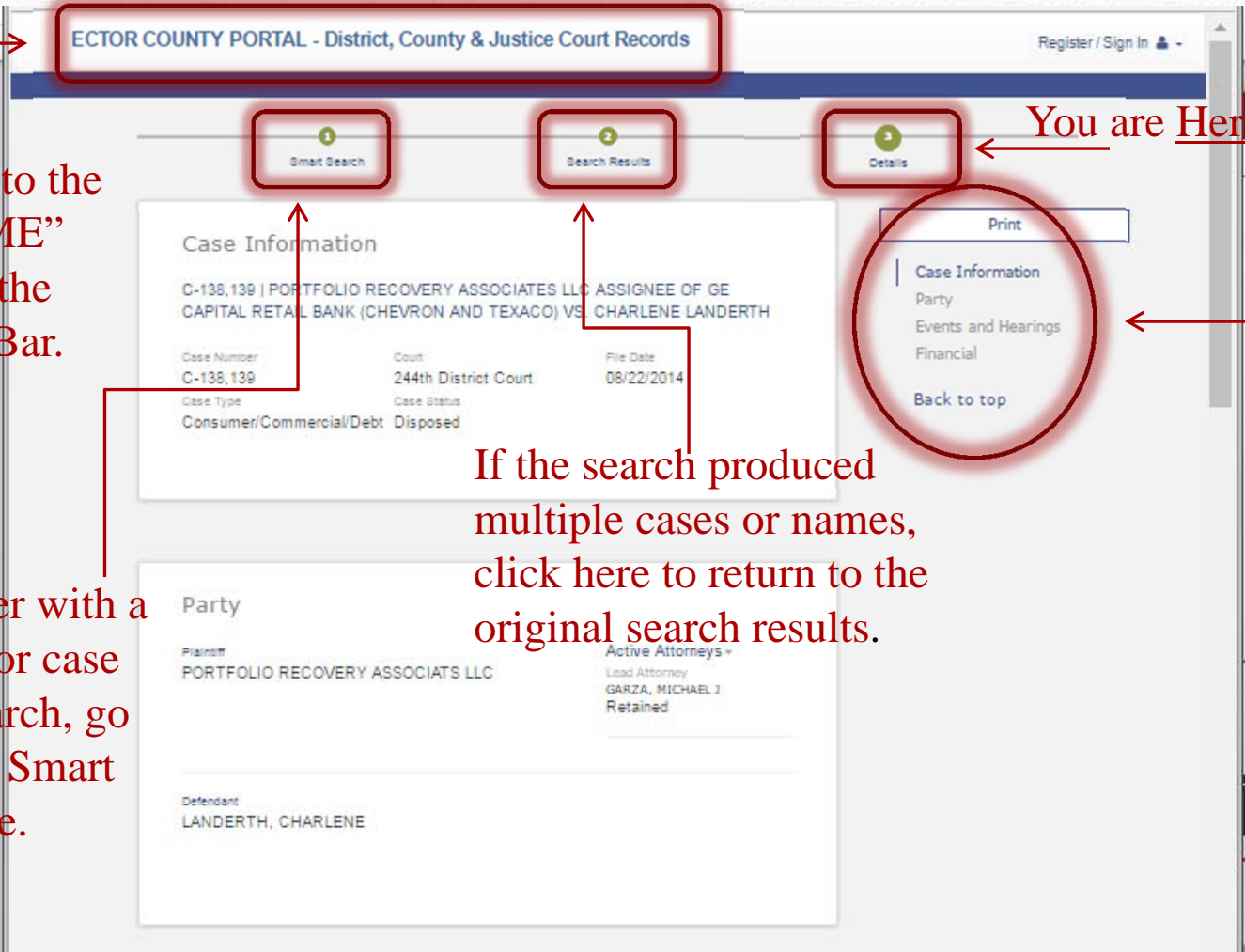

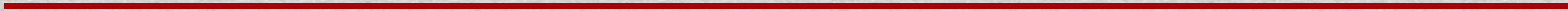

PLAINTIFF'S NOTICE OF NON-SUIT

COMES NOW Plaintiff PORTFOLIO RECOVERY ASSOCIATES LLC ASSIGNEE OF GE CAPITAL RETAIL BANK (CHEVRON AND TEXACO) ("Plaintiff") and, in accordance with the Texas Rules of Civil Procedure 162 and 163, provides its Notice of Nonsuit of all of its claims against Defendant CHARLENE LANDERTH ("Defendant") without prejudice in the above-styled lawsuit.

Pursuant to existing case law, Plaintiff has a right to a nonsuit the moment it makes a timely oral or written request for nonsuit. *Hooker v. Fourth Ct. Of Appeals*, 803 S.W.2d 56, 59 (Tex.1991). A nonsuit is effective as soon as it is filed or requested from the court. *Greenberg v. Brookshire*, 640 S.W.2d 870, 872 (Tex.1982). When the court signs an order granting a nonsuit, it is simply a ministerial act. *Id.* A nonsuit nullifies the controversy and renders interlocutory orders in the case moot. *In re Bennett*, 960 S.W.2d 33, 38 (Tex.1997).

In accordance with the foregoing authority, Plaintiff hereby provides notice of its immediate nonsuit of all claims against Defendant in the above-styled lawsuit without prejudice.
