#### **ORDINANCE NO. 2024-30**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ODESSA, TEXAS, CALLING AND ORDERING THE 2024 GENERAL CITY ELECTION TO BE HELD ON NOVEMBER 5, 2024, FOR THE PURPOSE OF ELECTING THE MAYOR AND THREE MEMBERS TO THE CITY COUNCIL: CITY COUNCIL DISTRICTS ONE, TWO, AND AT-LARGE; AGREEING TO PARTICIPATE IN A JOINT ELECTION; PROVIDING FOR ELECTION PROCEDURES AND EARLY VOTING; DESIGNATING THE ELECTION DAY VOTE CENTERS; PROVIDING FOR NOTICE OF THE ELECTION; FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED WAS NOTICED AND IS OPEN TO THE PUBLIC AS REQUIRED BY LAW AND DECLARING AN EFFECTIVE DATE

#### BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF ODESSA, TEXAS

Section 1. That there is hereby called and ordered to be held on November 5, 2024, a General City Election for the purpose of electing the mayor and three members to the City Council: Districts One, Two, and At-Large, for four-year terms.

Section 2. That said election is to be held between the hours of 7:00 o'clock a.m. and 7:00 o'clock p.m. on the above-described date.

Section 3. That all candidates who desire to have their names placed on the official ballot of said 2024 General City Election for any of the above-mentioned offices shall file a written application for same with the City Secretary of the City of Odessa no sooner than July 20, 2024, and no later than August 19, 2024, the 78<sup>th</sup> day before election day.

Section 4. That the City Council agrees to participate in a joint election with other entities and to pay its part of the cost as determined by the Elections Administrator.

Section 5. That said election shall be held in compliance with the provisions of the Texas Election Code applicable thereto, insofar as practical.

Section 7. That the voting shall be done by an electronic voting system as provided by law.
