**CONSIDERATION OF TAX ABATEMENT APPLICATION AND PROPOSED AGREEMENT.** To consider, receive public comment upon, and act upon an application and proposed agreements for property tax abatement under Chapter 312 of the Texas Tax Code for the following proposed project:

Property Owner: Matheson Tri-Gas, Inc.

Applicant for Tax Abatement: Matheson Tri-Gas, Inc.

Enterprise / Reinvestment Zone: 4.056 acre tract, lying within and being part of Section 3, Block 15, Public School Survey, Abstract 484, Ector County, Texas; with such tract being located in a Reinvestment Zone of Ector County, Texas designated by the Ector County Commissioners Court on December 14, 2023.

Anticipated Improvements: Construction of an Air Separation Unit (ASU) plant to increase their current production of gaseous oxygen, liquid oxygen, liquid nitrogen, and liquid argon.

Estimated Cost of the Improvements: \$85,000,000.00


