Notice About 2024 Tax Rates

Property tax rates in Ector County.

This notice concerns the 2024 property tax rates for Ector County. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The nonew-revenue tax rate would Impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

Voter-Approval Tax Rate Adjustments

State Criminal Justice Mandate

The Ector County County Auditor certifies that Ector County County has spent \$1,016,273 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. Ector County County Sheriff has provided Ector County information on these costs, minus the state revenues received for reimbursement of such costs. This increased the voter-approval tax rate by 0.002524/\$100.

Indigent Health Care Compensation Expenditures

The Ector County spent \$657,796 from July 1, 2023 to June 30, 2024 on enhanced indigent health care at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$208,535. This increased the voter–approval tax rate by 0.001041/\$100.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
