Current Property Owner: Rocky Mountain Energy Holdings, LLC

Applicant for Tax Abatement: Van Zandt Energy Storage LLC, a Delaware limited liability company.


Enterprise / Reinvestment Zone: A 20.7391-acre tract along South Grandview Avenue, with such tract being located in Precinct 4 of Ector County, Texas and designated by Ector County as a portion of Property ID 42430.00010.00000.

Anticipated Improvements: Construction of a 250 MW – 2 hour standalone Battery Energy Storage System (BESS) facility, process components, related buildings, utility, infrastructure, and logistics improvements, and any and all other forms of real property improvements and tangible personal property associated with the foregoing.

Estimated Cost of the Improvements: \$200,000,000.00
